#### ANNUAL AUDIT RESOLUTION

WHEREAS, N.J.S.A. 40A:5-4 requires the Governing Body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the year 2020 has been filed by a Registered Municipal Accountant with the Borough Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the Governing Body; and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the Governing Body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the Governing Body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations"; and

• WHEREAS, the members of the Governing Body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations", as evidenced by the group affidavit form of the Governing Body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the Governing Body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local Governing Body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

WHEREAS, N.J.S.A 33:1-12.20 states that a new consumption license may be issued to a person or business entity who operates a hotel or motel containing at least 100 guest sleeping rooms under the hotel exception; and

WHEREAS, a municipality may issue such a license even though a new consumption license cannot be issued in the municipality due to the limitation on licenses by population under N.J.S.A 33:1-12.20; and

WHEREAS, under N.J.S.A. 33:1-19.1 and 19.2, it is required that in order to issue a new license using the historical method, the municipal governing body shall adopt a resolution indicating its intent to do so; and

WHEREAS, the Borough adopted such resolution on December 1, 2021; and

WHEREAS, the Borough published a notice of the proposed issuance and that applications would be accepted by the Borough Clerk on January 18, 2022, no later than 12 O'clock Noon; and

WHEREAS, such notice was published not less than two times in the newspaper, one week apart, with the last publication done no less than 30 days prior to the specified date and time on the dates of December 9 and 17 of 2021 in the Asbury Park Press; and

WHEREAS, the Borough received one application submitted by WLB EMPIRE, LLC. and it was determined that the application was complete, in order, and the applicant followed the necessary publication requirements on their part; and

WHEREAS, the Borough believes that it would be in the public's best interest to award the one consumption license under the Hotel/Motel Exception to WLB Empire, LLC;

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of West Long Branch awards a new alcoholic beverage consumption license pursuant to the hotel/motel license exception as described in N.J.S.A 33:1-12.20 via the process of the historical method to WLB EMPIRE, LLC.

#### RESOLUTION ACCEPTING PROPOSAL FOR ENGINEERING AND PROJECT MANAGEMENT SERVICES FOR THR FRANKLIN LAKE HYDRILLA MANAGEMENT PROGRAM

WHEREAS, the Borough of West Long Branch has had a contractor treat Franklin Lake to eradicate and restrict the growth of invasive vegetation species, particularly Hydrilla;

and

WHEREAS, such contractor has completed the two-year contract to provide such services; and

WHEREAS, the Borough Engineer has submitted a proposal for Phase VI of the Franklin Lake Hydrilla Management Program (Contract for 2022-2024); and

WHEREAS, such program also includes control of the emergent plants along the stream corridor for approximately 900 feet toward Parker Road, which is an area of concern due to growth of excessive vegetation;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of West Long Branch that the attached proposal from Borough Engineer Francis Mullan of T&M Associates be accepted for Phase VI of the Franklin Lake Hydrilla Management Program (Contract for 2022-2024); and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to sign any attachments related to the proposal, indicating the Borough's acceptance.
