## **BOROUGH ATTORNEY BAXTER:**

1. As a result of complaints regarding trucks and vans parked in residential zones, the Borough Attorney reviewed the Borough ordinance and met with the Police Chief and both Lieutenants to discuss the interpretation of the ordinance and how it should be applied. Some questions have been raised. For example, there is no definition of a commercial vehicle in the ordinance. There is also a weight limitation included in the current ordinance that may no longer be required if there is a vehicle description. Based on observations of one police officer, there are approximately 100 violations existing. The Borough Attorney recommended to the Police Chief that the Police Department not take action on these violations while these questions exist. It was determined that this matter be turned over to the Ordinance Review Committee for further discussion at a meeting to be held on Thursday, February 23rd, at 6:30 PM, or as soon as the already scheduled special meeting that evening concludes. The Police Chief, two Lieutenants. and Borough Attorney will also be present at the meeting.

Councilman Neyhart moved that the Council enter Executive Session at 6:49 PM. Seconded by Councilman Bray and carried unanimously.
