Councilman Neyhart suggested adding the processing, farming, and growing of marijuana as well. The ordinance will be amended to include those items. Thereafter, the Borough Attorney will forward the proposed ordinance to the Borough Administrator to be sent to the Planning Board.
- 3. A resolution to amend the 2018 meeting schedule to accommodate the Jewish holiday of Yom Kippur will be considered for adoption at tonight's regular meeting.
- 4. A resolution to set the procedure for refunds of 2018 taxes that were paid in 2017 because of the new tax code will be considered for adoption at tonight's regular meeting.
