- _____ 2. Rendered confidential by State Statute or Court Rule.

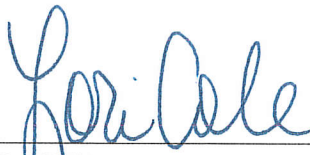
- ☐ 3. Would constitute an unwarranted invasion of individual privacy.

- ☐ 5. Deals with purchase, lease or acquisition of real property with public funds.
- ☐ 6. Related to setting of bank rates or the investment of public funds and disclosure could adversely affect the public interest.
- ☐ 7. Related to tactics and techniques utilized in protecting the safety and property of the public and disclosure may adversely affect the public.
- ☐ 8. Related to investigation of violations or possible violations of the law.
- ☒ 9. Related to pending or anticipated litigation or contract negotiations in which the public body is or may be a party.
- ☒ 10. Falls within the attorney-client privilege and confidentiality is required.
- ☒ 11. Deals with personnel matters involving the employment, appointment, termination of employment, terms and conditions of employment, performance evaluation or discipline of any public officers or employees, either current or prospective, and all of the employees or appointees whose rights could be adversely affected have not requested that the matter be discussed publicly.

COUNCILMAN NEYHART:

1. There have been complaints that there are six trees in the vicinity of the Old Borough Hall/Library/Community Center that are dead and one that hangs over the building that need to be addressed. The Public Works Department may be able to handle this project.
2. The West Long Branch Community Center has been having issues with the gutters on their building. Since the old municipal building will be demolished, Community Center representatives asked if it was possible to salvage the gutters for use on their building.
3. The Borough Administrator was asked to have the demolition contractor save a couple of pieces of the old municipal building for display at the Old First United Methodist Church Museum.

Councilman Neyhart moved Council adjourn Caucus Session at 7:56 PM, seconded by Councilman Bray, and carried unanimously.
