Mayor Janet W. Tucci presided.

Mayor Tucci reported that in accordance with N.J.S.A. 10:4-6 adequate notice of this meeting of the Mayor and Council has been provided.

Mayor Tucci turned the meeting over to Councilman Cioffi, who serves as the Liaison to the West Long Branch Emergency Medical Services, for the West Long Branch Emergency Medical Services Recognition Awards.

Councilman Cioffi announced that members of the West Long Branch Emergency Medical Services would be recognized this evening for achieving the required number of hours for the President's Volunteer He explained that the President's Volunteer Service Service Award. Mayor Tucci opened the meeting up to the public.

Thomas Fishkin, 128 Beechwood Avenue, appeared this evening concerning the speeding problem in town. He mentioned that rumble strips were installed on some streets in the past to deal with the problem. He asked if it was possible for the Police Department to increase patrols, especially during the morning/evening rush hours when the problem was especially evident. Councilman Neyhart advised that he has had conversations with the Police Chief about the problem, and the Police Department has been actively addressing it. Mr. Fishkin specifically mentioned Mount Drive being used as a cut through and pointed out that other municipalities have restricted vehicles from cutting through certain neighborhoods. Councilman Neyhart indicated that he wasn't in favor of that proposal.

Mr. Fishkin also reported that the house across the street from his has a hedge row that made it difficult to see. The Borough Administrator was asked to notify the Code Enforcement Officer of this complaint. Councilman Cioffi encouraged Mr. Fishkin to also e-mail the complaint to the Code Enforcement Officer.

There being no one else wishing to speak, Councilman Neyhart moved Council adjourn Caucus Session at 7:53 PM. Seconded by Councilman Bray and carried unanimously.
