A caucus meeting of the Mayor and Council of the Borough of West Long Branch was held on the above date and time in the Council Chambers, Borough Hall, 965 Broadway, West Long Branch, N.J.

Mayor Janet W. Tucci presided.

Mayor Tucci reported that in accordance with N.J.S.A. 10:4-6 adequate notice of this meeting of the Mayor and Council has been provided.

ABSENT: PENTA

In accordance with the discussion at the February 23<sup>rd</sup> special meeting, Councilman Bray asked the Mayor and Council if they had reviewed the Budget/Revenue Preparation Worksheet and wanted to discuss any of the line items further or had any questions. The Acting Administrator/Borough Clerk stated that the Auditor confirmed that the Borough must introduce the budget by March 17<sup>th</sup> or the next regular meeting, which is April 5<sup>th</sup>.

Councilwoman Juliano questioned/commented on the following budget items:

- Page 14, Line Item 7-01-20-175-000-204 Historical Projects at Large What are the projects at large?
- Page 28, Line Item 7-01-23-390-000-216 Library Maintenance This item was reduced from \$10,000 to \$5,000.
- Page 38, Line Item 7-01-25-260-000-225 F.A.S. Vehicle Repairs It was determined to leave this line item at \$6,500.
- Page 46, Condo Services Trash; Snow Removal; St. Lights These line items cover the required reimbursements to the three condominium associations The Mews of Turtle Mills; Whispering Meadow; Winding Brook.
- Page 52, Line Item 7-01-26-310-000-228 Pub Bldgs IT Provider This appropriation will be used to pay the new company when a change from the current provider is made.

• Page 55, Line Item 7-01-26-313-000-295 – Shade Tree – Dead Tree Removal – It was determined that this appropriation was necessary in the event a dead tree needed to be removed.

No one else had any comments or questions.

Councilman Bray confirmed with the C.F.O., who was in the audience, that he is working with the Auditor on putting the budget together for introduction at the April 5<sup>th</sup> meeting.

# **BOROUGH ATTORNEY BAXTER:**

- 1. The Prosecutor, Joe Hughes, will cover for the Borough Attorney at the March 15<sup>th</sup> meeting of the Mayor and Council.
- 2. The Ordinance Review Committee met with the Police Chief, two Lieutenants, and Borough Attorney on February 23<sup>rd</sup> to discuss the ordinance concerning trucks, vans, and other commercial vehicles. The Borough Attorney prepared and submitted a memo to the Ordinance Review Committee outlining the items that were discussed at that meeting. The next step will be to draft an ordinance for review by the Ordinance Review Committee before the matter is brought forth to the entire Council.
- 3. The Borough Attorney prepared a letter, dated February 24th, to the Mayor and Council outlining the requirements for the termination of the Length of Service Awards Program, if the Governing Body is so inclined. First, there must be an ordinance adopted to undertake the termination of the program. The Borough Attorney suggested sending any such ordinance to the Department of Community Affairs for review prior to action by the Borough Council. After the ordinance is adopted, the issue must be put to public referendum. Further, if the Council desires to proceed with this matter, he recommended acting on the ordinance in June. The Borough Attorney pointed out that Mayor Tucci and Councilman Migliaccio are conflicted out of action on this matter.

Judge McGoughran is scheduled to cover for him during the month of March.
