A caucus meeting of the Mayor and Council of the Borough of West Long Branch was held on the above date and time in the Council Chambers, Borough Hall, 965 Broadway, West Long Branch, N.J.

Mayor Janet W. Tucci presided.

Mayor Tucci reported that in accordance with N.J.S.A. 10:4-6 adequate notice of this meeting of the Mayor and Council has been provided.

COUNCILMAN BRAY:

1. In furtherance of the discussion at the June 7th meeting regarding items to be included in the Monmouth County Improvement Authority's Capital Equipment Lease Program, the following items required further consideration:

DPW - 2017 Garbage Truck - \$241,000 – It was determined that this item is needed.

DPW - 2017 Ford F-450 4x4 Dump Body & Snow Plow - \$53,000 - It was determined that this item is needed and will replace an older vehicle.

DPW - 2017 Ford F-250 XL regular Cab 4x4 & Snow Plow – It was determined that this item is needed and will replace an older vehicle.

Fire Department - Chief Vehicle (Explorer) - \$34,000 & First Aid Squad - First Aid Squad Captains Vehicle - \$50,000 - Councilman Migliaccio reiterated his comment from the June 7th meeting that both vehicles should be the same type. It was decided to purchase Explorers for both the Fire Department and the First Aid Squad.

Police – Police Tahoe - \$50,000 – The Borough Clerk noted that information from the Police Chief has been posted in Dropbox comparing the Chevrolet Tahoe and the Ford Utility Vehicle. It was decided to purchase the Chevrolet Tahoe.

BOROUGH CLERK COLE:

1. When the list of meetings for calendar year 2017 was prepared for approval at the reorganization meeting, the Borough Clerk picked up the second Wednesday of August (August 9th) instead of the first Wednesday (August 2nd) for that month's meeting. No one had an objection to leaving the meeting on August 9th as it was advertised.

BOROUGH ATTORNEY BAXTER:

1. The Borough Attorney made the changes to the truck and van ordinance based on the discussion at the last meeting. The Borough Clerk reminded everyone that this matter was referred back to the Ordinance Review Committee for further discussion. It was determined that the Ordinance Review Committee will meet on August 2nd, at 7:00 PM.

The Emergency Management Coordinator, Steven Cioffi, was in attendance this evening to give the following report on this year's fireworks display:

- 1. He confirmed that the Mayor and Council did not receive any complaints.
- 2. The shoot site was moved from the ballfield to the asphalt parking lot this year.
- 3. Everything went well and all departments (Police Department, Fire Department, First Aid Squad, and Public Works) put forth their best efforts.
- 4. The concrete garbage pails were removed and replaced with Bag Buddies to address Homeland Security issues.
- 5. There was a lot of debris from the fireworks left at the shoot site that was required to be cleaned up the next day.

Councilman Bray moved that the Council enter Executive Session at 6:58 PM. Seconded by Councilwoman Mango and carried unanimously.
