"The 2023 budget that we are introducing tonight is the result of budget hearings with individual council committees, as well as numerous meetings with the Finance Committee, Council and our CFO, Michael Martin. I would like to thank all parties involved, especially Finance Chairman, Councilman Stephen Bray, for the hard work and cooperation that went into the development of this budget. The total 2023 budget of \$13,522,284.35 has been <u>decreased</u> by \$52,801.01, over the 2022 budget of \$13,575,085.36. This budget provides funding to maintain staffing and equipment for important public safety functions. It maintains the ability to keep our public

facilities and roads in a state of good repair. We also continue to invest in our facilities and roadways through capital improvement projects. An annual inspection is made of all Borough roadways to prioritize those most in need of attention.

TAX RATE

The 2023 tax levy, which is the entire amount of money to be raised by direct taxation, provides a municipal tax rate of 45.35 cents. This represents a reduction of 6.74 cents in the tax rate from 2022. The tax rate is the rate per \$100 of assessed value to arrive at the levy. Our Borough did experience an increase in Property Valuations of 17.70% over the 2022 Property Valuations. Taxes on an average home in West Long Branch assessed at \$872,479 for <u>municipal</u> <u>purposes</u> will be \$3,956.65. This is only a \$150.48 increase over last year. The balance of taxes is for the local and regional schools and the county.

REVENUES

Revenues for the Borough have remained stable throughout the 2022 budget year, and we have anticipated similar amounts for the 2023 Budget. The amount of State Aid anticipated from the State of New Jersey increased for 2023 by \$47,034.26 to a total of \$843,203.26. The amount of Surplus utilized is the same as the 2022 amount of \$947,600.

APPROPRIATIONS

The Finance Committee has worked very diligently to control expenditure within the departments. Most of the departments were held at the same appropriation levels as in 2022. This year the Borough plans to appropriate over \$1,100,000.00 for Road Paving and Sidewalk Projects partially funded by NJ Department of Transportation Grants. A note of appreciation is due to both our taxpayers and our tax collector, Laura Amada, for achieving a tax collection rate of 98.76% The public hearing on the 2023 Municipal Budget is set for May 24, 2023."

Councilmember BRAY offered the following resolution and moved its adoption. The motion was seconded by Councilmember SNIFFEN.
