## REPORTS OF STANDING COMMITTEES:

Mayor Tucci asked that the Borough Administrator to coordinate with the West Long Branch Community Center to utilize their sign to announce Borough events. She also mentioned that guidelines would be posted for Halloween.

Councilman Bray confirmed that the Borough Administrator and Chief Financial Officer had completed the Best Practices Inventory, which would be submitted on October 28th, and that the Borough was in compliance.

Councilman Bray reported that construction on the new roof at the West Long Branch Community Center would begin this week, and the contractor anticipated obtaining permits for the interior work next week.

Councilman Cioffi read the following report:

### First Aid Report/ Month of September:

Our Emergency Medical Services answered 72% of the calls for the month of September. They had a total of 69 calls for service for the month, which was a slight decrease from the month before of 71 calls. A total of 48 of these calls were answered by our squad, 19 were answered by mutual aid agencies and our squad handled 2 mutual aid for other towns.

The new very welcomed Stryker Loader Power Stretcher that was recently purchased by the town was placed in service by the squad and seems to be an essential tool in answering calls for service in the borough.

The new radios that had been purchased through the grant that the squad had obtained were placed in service and the Captain has set the guidelines and assignments for them.

Prior to last council meeting I met with them line officers of the squad and they expressed several items of concern that was brought back to the committee and once decisions are made, those decided items will be brought back to the governing body. Lastly, The committee has recently moved forward to take the ambulance (5356) that has been out of service for months and retire it and sell it in auction. Further details on that will be reported.

Councilman Cioffi read the following report:

### Fire Department Report /Month of September:

Our Fire Department responded to a total of 26 calls for the month of September which was a decrease from the month before with a total of 64 responses.

One of the categories of the responses that caught my attention in these numbers over the past two months was "Fire Alarms" Overall the number of Fire alarms seem to have increased throughout the past months and I will be having the Chiefs look into it, and to determine if the false alarm ordinance which we have in place needs to be enforced and if so, to do so.

Lastly I will be meeting tomorrow with the Chiefs of the department & the Fire Department Records administrator and present a plan that they have been working on to my fire committee for further review. I will update the governing body once this is completed and decided on.

Councilman Cioffi read the following report:

### **Emergency Management-**

Yesterday, myself along with the Borough Administrator joined in on a conference call to Dave Henry of the Monmouth County Regional Health Department. Myself and the administrator had orchestrated the call to the health department in hopes to get a better understanding of how the positive COVID testing count is completed and tallied for our municipality. We explained the many different numbers that are being brought forward which currently seems to be a "Roller Coaster effect because of the number of positives we have in town going up and down. We also questioned recovery rate and how that was determined.

Dave then stated he understood our concerns and was was very instrumental in explaining how testing is done, also the process of their reporting and just how they, the health department, arrive to get to a final total. He also stated that his office has been involved and will continue to work side by side with Monmouth University staff & provide them recommendations & guidelines to follow in hopes to decline these numbers. As far as recovery numbers, State Health has stated that after 10 days of self-isolation the person is considered recovered.

He stated that West Long Branch was considered a "Hot Spot" due to the amount of positives that were being reported, but this was clearly contributed with what was referred to by many as the "Super Spreader Event Party" that several students attended off campus in another municipality and then returning to campus. He also said that all the indications from recent testing and learned data our numbers will go in a downward direction but they will continue & closely be watching the university for any upticks and give them guidance where needed.

We thanked him for answering our concerns and we agreed that the University from the start has been proactive on their efforts to work with the municipalities, especially ours and they also seem to have an open door type of communication with us. He advised that he would keep us in the loop for sure and any questions that we had, our governing body had or even the public, feel free to contact him at any time and if he didn't have the answer he would get it for us.

Mayor Tucci stated that she went on record during a recent conference call with the Governor's Office that the current COVID numbers being reported for West Long Branch were not indicative of the town, but rather the result of a Monmouth University super-spreader event.

On behalf of Councilwoman Mango, Mayor Tucci reminded everyone that the Environmental Commission would be hosting their semi-annual recycling event on Saturday, October 24th, from 8:00 AM to 12:00 PM, in the Borough Hall parking lot. The Mayor asked the Borough Administrator to reach out to the Environmental Commission Chair to find out what residents should do with their plastic bags.

Councilman Sniffen reported that the trailer for the Recreation Commission was ready. He also mentioned that the Recreation Commission Chair found some Christmas season items to purchase and put up around town.

Councilman Neyhart thanked Councilman Sniffen for coordinating the cleanup of the Valenzano Park storage building.

There was nothing to report on behalf of the Shade Tree Commission.

Councilman Neyhart reported that the West Long Branch Police Department would be participating in the DEA's National Prescription Drug Take Back Day at Peter Cooper Village on Thursday, October 22<sup>nd</sup>, from 11:00 AM to 12:00 PM, and Police Headquarters on Saturday, October 24<sup>th</sup>, from 10:00 AM to 2:00 PM.

Councilman Neyhart reminded residents that the Borough's curfew was in effect from October 29th through November 1st, from 8:30 PM to 6:00 AM.

Councilman Penta reported that one of the garbage trucks has been auctioned for approximately \$30,000 through GovDeals and noted that there was another truck to be sold.

Councilman Penta proposed instituting a fee of \$5 per item (\$10 for heavier items) to obtain a sticker to be placed on bulk items to be collected. Under his proposal, the collection dates would not change. He felt that the revenue from this program could be used for pothole and road repairs. The Borough Attorney confirmed with the Chief Financial Officer, who was in the audience, that any funds collected under this program would be deposited into the Borough's general account. Mayor Tucci asked Councilman Penta and his Committee to investigate this proposal further before proceeding.

# RESOLUTION OPPOSING THE CONSTITUTIONAL AMENDMENT LEGALIZING RECREATIONAL USE OF MARIJUANA

WHEREAS, in the 2020 General Election, New Jersey voters are being asked to approve or disapprove an amendment to the State Constitution that legalizes the use of cannabis and cannabis-related products, including marijuana, for persons 21-years-of-age and older; and

WHEREAS, a bill to accomplish a similar effect failed to pass the Legislature; and

WHEREAS, the constitutional amendment does not limit the amount of tetrahydrocannabinol (or THC, the chemical in cannabis that induces the "high") that can be present in cannabis products ("pot"). In states where pot is legal, products are sold that have 99% THC content; and

WHEREAS, it is a well-established medical fact that the habitual use of pot with high THC content can have detrimental mental health effects, especially on teenagers and young adults whose brains are still developing and are susceptible to severe psychosis, such as schizophrenia; and

WHEREAS, the constitutional amendment also does not limit the types of cannabis products that can be sold and consumed; and

WHEREAS, in states where recreational pot is legal, cannabis is sold in candy forms, such as gummies and chocolates, and oils used in vaping devices; and

WHEREAS, because THC consumed via edibles can take hours to be absorbed and provide the sought after "high," it is common for consumers to overdose on edibles, inducing hallucinations, paranoia and/or severe nausea; and

WHEREAS, the constitutional amendment does not guarantee that municipalities cannot be forced to allow pot stores within their borders; and

WHEREAS, since recreational pot has been legal in Washington State, traffic deaths involving stoned drivers have increased; and

WHEREAS, surveys have shown that underage use of marijuana has increased since its legalization around the country, especially in those states where pot is legal; and

WHEREAS, according to the Legislature's non-partisan professional staff, the constitutionally imposed tax on cannabis products will raise merely \$126 million in State revenue or just 0.031% of Governor Murphy's \$40 billion-plus proposed FY'21 budget; and

WHEREAS, this paltry new revenue is not likely to cover the lost revenues from the businesses adversely affected by legal pot, combined with the new costs resulting from the added regulatory bureaucracy and dealing with negative health

consequences of legal pot. It is possible, therefore, that legal pot could cost New Jersey taxpayers money; and

WHEREAS, the preceding facts clearly demonstrate that it is utterly inappropriate and dangerous to use the Constitution of the State of New Jersey as the means to legalize the recreational use of marijuana.

NOW, THEREFORE, BE IT RESOLVED that the Monmouth County Board Chosen Freeholders oppose the constitutional amendment legalizing recreational use of marijuana and urges voters to vote "No" on the ballot question.

BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this resolution to Governor Phil Murphy; the President of the New Jersey State Senate; the Monmouth County Legislative Delegation; the New Jersey Association of Counties; all Municipal Mayors and Administrators and all other Boards of Chosen Freeholders.
