






Existing Front (West) Elevation Carriage House 1/4" = 1'-0"








Proposed First Floor Plan Carriage House Demo Plan 1/4" = 1'-0"




Proposed First Floor Plan Carriage House




Proposed Second Floor Plan Carriage House Demo Plan
