Summary

- The property contains an existing single-family dwelling. The applicant has submitted a
 variance application to Construct a single-story addition along the left side, as well as a
 second story addition above the garage. The property is located within the R-15 Zone
 and has access from Stevens Ave.
- The applicant proposes to expand the existing dwelling via 3 additions thereto. Two of the additions will each be a single story and consist of 99 square feet and 143 square feet in area. The third addition will be a second-floor addition above the existing attached garage. Mr. Waga testified that the second-floor addition will vertically extend the deficient front yard setback of the structure from the Cooper Avenue frontage. One of the proposed single-story additions will laterally extend the deficient front yard setback of the dwelling from the Stevens Avenue frontage. Mr. Waga pointed out that the lot lines of the property are "skewed". He confirmed that the proposed expanded dwelling will continue to conform to Ordinance height limitations, and he added that the exterior of the proposed additions will be sided to match the existing dwelling facade.
