### Summary

- The property contains existing office space. The applicant has applied a Use Variance and
  Preliminary and Final Site Plan to demolish the existing structure and construct a "162-unit Agerestricted multifamily senior living building" on the referenced site. The property is located at
  the corner of Parker Rd and Monmouth Road in the RP zone. Access to the site is from both
  Monmouth and Parker Roads
- Mr. Miklich gives testimony about the description of the project. The Independent Living residents would typically stay three to four years. Whereas the Assisted Living resident usually comes in with a little more of an advanced physical decline, their stay is more in the 18-month, 24-month range. But in terms of the actual services that the residents receive, the main difference is care. The independent living residents, when moving in and they see the activities on site and the transportation that we offer, they rarely use their car.
